## 9. SCHEDULES

### SCHEDULE 1 – CRITICALLY ENDANGERED ECOLOGICAL COMMUNITIES AND ENDANGERED ECOLOGICAL COMMUNITIES BY RESERVES

An ecological community is a naturally occurring collection of native plants, animals and other organisms occupying a particular area. Ecological communities are threatened when they become at risk of extinction. The *Biodiversity Conservation Act 2016* lists over 100 threatened ecological communities (TEC), the table below identifies which TEC are present on Community Land within the Camden LGA.

Council has responsibilities as part of coordinated efforts to maximise long term survival of threatened species or ecological communities. These have been identified within relevant recovery plans listed under the *Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)* and previously under the *NSW Threatened Species Conservation Act (1995)*.


